RE: SFY 2024 Allocation of Funds to Date

The Ohio Department of Job and Family Services Office of Workforce Development (ODJFS/OWD) executes subgrant agreements with each local workforce area (LWA) for the duration of the State Fiscal Biennium to authorize LWA expenditures of Workforce Innovation and Opportunity Act (WIOA), Reemployment Services and Eligibility Assessment (RESEA), National Dislocated Worker Grants (NDWGs), the Temporary Assistance to Needy Families (TANF) portion of Comprehensive Case Management and Employment Services (CCMEP), WIOA Statewide Special Projects funds, and ODJFS' portion of shared costs under the local OhioMeansJobs (OMJ) Memoranda of Understanding (MOU).

Title 2 Part 200.332 of the Code of Federal Regulations (CFR) outlines responsibilities for pass-through entities, which includes providing federal award and subaward funding details to subrecipients. However, the funding information for all subawarded funds is not available at the time of agreement execution. ODJFS has opted to exclude funding details other than award titles and Catalog of Federal Domestic Assistance/Assistance Listing Numbers (CFDA/AL) from the subgrant agreements as it would be an administrative burden for both ODJFS and the LWAs to amend the subgrant agreements each time ODJFS allocates funds to LWAs throughout the State Fiscal Biennium. Therefore, ODJFS will distribute allocation memoranda to each LWA for each allocation. This memorandum will provide the federal award and ODJFS subaward information for the State Fiscal Year (SFY) 2024 allocations that have been issued to date.

It is important to note that budget notices will continue to be generated by the County Finance Information System (CFIS), which will be supplemental to these allocation memoranda and include the beginning, end, and subaward dates for all allocations.

In addition to the terms and conditions of the WIOA subgrant, WIOA, and the corresponding federal regulations, LWA expenditures must be in compliance with the applicable provisions of the federal Uniform Guidance and Cost Principles in Title 2, Part 200 of the Code of Federal Regulations (CFR) and the DOL exceptions in 2 CFR 2900.

As a pass-through entity, the LWA must follow the requirements in Article XII, Section C of the WIOA subgrant agreement.

LWA expenditures for NDWGs and WIOA Statewide Special Projects must be in accordance with the approved funding application and budget. Any changes in plan activities or the budget will require LWA submission of a revised application and budget and will require approval by ODJFS.

Expenditures of funds allocated for ODJFS' share of OMJ MOU costs must be in alignment with the budget submitted with the MOU that ODJFS approved. Updated budgets from quarterly reconciliations per Article VI, Section B of the MOU must be distributed to ODJFS and other partners in a timely manner. Any other changes to the budget must follow the amendment procedure outlined in Article VII of the MOU.
